SPECIAL MEETING

PRESENT Council Members: Mayor Adams, Niki Hutto, Linda Edwards, Betty Boles, Johnny Williams, and Barbara Turnburke; City Manager; and Chris Trainor of the Index-Journal.

CALL TO ORDER The special meeting in Council Chambers was called to order by Mayor Adams at 5:35 p.m.

STATEMENT AND QUORUM Mayor Adams read the following statement, "In accordance with the Freedom of Information Act, Chapter 4, Title 30, Code of Laws of South Carolina, 1976, an agenda has been posted on the front door of City Hall and notification of this meeting has been given to the news media."

Ordinance No. 09-025 Amending the City of Greenwood's Official Zoning Map (Ordinance No. 04-020) by Rezoning Properties Located at 310, 412, 420 & 430 Bypass 72 Northwest and 1203 Montague Avenue Extension from GC (General Commercial) to PDD (Planned Development).

Motion to accept was made by Niki Hutto, seconded by Johnny Williams.

\$18,750 to be dispersed to law enforcement agencies in the 8th Judicial Circuit.

\$6,250 to be used for traffic enforcement purposes by the City of Greenwood.
